The Idaho Commission for Libraries FY11 state appropriation is a 34.5% decrease from the original FY09 state appropriation.



The Idaho Commission for Libraries administers Library Services and Technology Act (LSTA) funds through the Institute of Museum and Library Services.

## FY2009 LSTA competitive grant projects

In FY2009, public libraries in Idaho were awarded \$137,237 in Library Services and Technology Act (LSTA) funds for projects that support the Board of Library Commissioners' strategic issues for Idaho's libraries, are consistent with LSTA's priorities, and support the 2020 Vision for Idaho's Library Future 2007–2020. The libraries involved in the the following projects serve a total of more than 387,000 patrons:

- **Library Consortium of Eastern Idaho (LCEI):** \$45,703 to merge the catalogs of 20 LCEI libraries—reducing the number of servers needed and making local collections available to patrons consortium-wide.
- **Cooperative Information Network (CIN):** \$35,476 to add Priest Lake and West Bonner District to the network, add courier service, and add authority control for cataloging—improving the consortium and cataloging process.
- **Emmett Public Library:** \$56,058 to join the LYNX Consortium—providing a sustainable means to automate and to communicate with their patrons.

## FY2009 LSTA Continuing Education grant projects

Over \$36,000 in LSTA continuing education grant funds were used for 71 applicants for first-time attendance at library conferences, staff and trustee development, and support for formal library courses.

Bonita (Bonnie) Speas, library coordinator for the Caldwell School District and librarian at Jefferson Middle School, attended the American Association of School Librarians (AASL) National Convention and implemented some ideas that intrigued her, including:

- **Tech2Go for teachers:** she spotlights a different technology or Web 2.0 resource each week, which often increases student demand and teacher interest in that technology.
- **“Bookstore” style arrangement of some of the library collection:** she sets up tables with various genres such as Chic Lit, GUYS READ, and Historical Fiction, which attract student attention and keep the books circulating.

Jefferson Middle School (grades 6, 7, and 8):

- Over 700 students
- 48% Hispanic enrollment
- 77% of families are low income

## 12th annual Read to Me meeting

Sixty-one library staff members and four community partners representing 38 libraries from around the state left the 12th annual Read to Me meeting with action plans for reaching more underserved families in their communities.

- Head Start Association Executive Director Stan Burton urged librarians to remember the “Three Fs” when planning services for Head Start families: Fun, Food, and Familiarity.
- National Literacy Consultant Saroj Ghoting shared ideas on taking the six early literacy skills a step further.
- Reading Coordinator at the State Department of Education Jenny Fisk shared information about the Idaho Reading Indicator (IRI).
- Boise State University Department of Literacy's Dr. Roger Stewart shared his latest research results on Idaho's Read to Me programs, which indicate that, six to nine months later, parents who participate in the programs are continuing early literacy activities with their children.

Breakout sessions at the Read to Me meeting included tips on outreach to daycares and programming for English Language Learners.

## USDA Rural Development grants/loans

### Plummer Public Library

In November 2008 Plummer voters approved a \$500,000 bond to fund construction of a new library building. Financing for the bond was secured from United States Department of Agriculture (USDA) Rural Development. USDA also granted an additional \$95,000 of American Recovery and Reinvestment Act (ARRA) funds. The new building is scheduled to open July 5, 2010.

### Payette Public Library

Stimulus funds may inject new life into Payette in the form of an expansion of their library building. Results of a feasibility study commissioned in 2009 indicates that they could expand the current facility. The study included a proposed expansion design that would cost \$1.5 million. However, the project was put on hold due to the economic slowdown.

Early this year, Idaho libraries received word that the USDA Rural Development ARRA would be focusing on library construction projects. In light of the low interest rate provided by USDA/ARRA and matching grant funds, the city of Payette will hold an election on August 3 for a \$1.5 million building bond. If the bond passes, USDA will match the bond with \$400,000. An additional \$100,000 will be added through city funds. The bond amount will also be underwritten by USDA/ARRA at a 4% interest rate, and the library will seek partial interest reimbursement through the Build America Bond program or as a recovery zone facility.

## Statewide networking projects

LSTA funding of nearly \$250,000 supported the Libraries Linking Idaho (LiLI) program in FY2009 to facilitate online access to resources for all Idahoans. LiLI Unlimited is a web catalog for finding items in libraries statewide and the LiLI Databases provide access to the full text of magazines and newspapers.

### E-rate funding in public libraries

The Schools and Libraries Program of the Universal Service Fund, commonly known as the E-rate program, is administered under the direction of the Federal Communications Commission (FCC). Through the E-rate program, discounts are made available to eligible schools and libraries for telecommunication services, Internet access, and internal connections to ensure that they have affordable access to these services. In 2009-2010, thirty-three Idaho public libraries applied and were funded. So far in Wave 1 of 2010 E-rate funding, 40 libraries have received funding commitments.


### Broadband (BTOP) Proposal for Stimulus Funding

On March 15, the Idaho Commission for Libraries submitted a Public Computing Center Broadband Technology Opportunities Program (BTOP) grant proposal, "High Quality Public Computing in Idaho Libraries," to the National Telecommunications and Information Administration (NTIA). This proposal has advanced to the "due diligence" phase. The objectives of this project are to:

- increase connectivity rates in the least connected of Idaho public libraries
- upgrade public computing resources in those libraries
- leverage partnerships to offer services in education, workforce development, and e-government statewide

## Partnering to Shape 21st Century Learners conferences

At the Partnering to Shape 21st Century Learners conferences—held in Boise, Coeur d'Alene, and Pocatello in spring 2010—participants networked with colleagues and the famous ‘Washington Moms,’ who led a grass-roots campaign in Washington State to raise awareness of the importance of libraries on student academic success. School librarians served as team leaders and, along with an administrator and one or more parents, formulated blueprints for their 21st century libraries, envisioning inviting, teen-friendly places that promote global citizenship. The teams further explored building partnerships and discussed the Idaho School Library Impact Study findings (see below).

## Idaho School Library Impact Study—2009

In April 2010, the Idaho Commission for Libraries released the final report of the “Idaho School Library Impact Study—2009: How Idaho School Librarians, Teachers, and Administrators Collaborate for Student Success.” The Commission contracted with RLS Research Group for this study, which was endorsed by the Idaho Department of Education. Idaho is one of 20 states that have completed similar studies and the results are expected to be widely reported in library and educational journals and forums. ## Talking Book Service (TBS) transfer to LSTA funds

A series of cutbacks initiated during state FY2009 severely reduced the Commission's state funds. Although the Talking Book Service had been supported entirely by state funds, it is a direct service to the underserved, one of the target audiences for LSTA funds. The Board of Commissioners approved the transfer of personnel costs for seven TBS staff members and TBS operating costs such as the KLAS circulation system to LSTA funds. Idaho TBS focuses heavily on outreach via public libraries to help them better serve those requiring reading alternatives.

## 25 Years of Let's Talk About It book discussions

This year marks the 25th anniversary of “Let's Talk About It,” a statewide library program that brings readers and scholars together to discuss literature from various themes over the course of a season. Program participants expand their reading interests and explore important cultural issues in the context of their own lives and the lives of others. Since 1985 the program has been a partnership between the Idaho Commission for Libraries, the Idaho Humanities Council, and the Division of State Programs of the National Endowment for Humanities, with support for more than 12 years from US Bancorp.
