Broadband grant program update

On March 15 the Idaho Commission for Libraries submitted a Broadband Technology Opportunity Program (BTOP) Public Computing Center grant application, "High Quality Public Computing in Idaho Libraries," to the National Telecommunications and Information Administration (NTIA).

the project includes additional public access computers for only those libraries participating in the connectivity upgrades. However, online resources funded through the grant will be available statewide.

If our application meets the BTOP eligibility requirements and scores well against the evaluation criteria, we will move into the "Due Diligence" process. The reviewers assigned to our proposal may ask for additional information to clarify or to further document specific portions of our application.

NTIA intends to announce BTOP awards starting in June 2010, and to award all grants by September 30. I am confident that even if our BTOP application is not funded, the Commission will proceed to work with several of our project partners to develop some of the services we've planned. With or without BTOP funding, I believe that Idaho public libraries and the communities you serve will benefit from this application process. If you have questions or comments about our BTOP proposal, please don't hesitate to contact your public library consultant.

- increase connectivity rates in the least connected public libraries.
- upgrade public computing resources.
- leverage partnerships to offer services in education, workforce development, and e-government.

The total project budget is \$2,850,347. The grant request is \$1,907,531; the \$942,816 in matching funds consists of cash and in-kind from the Gates Foundation, the Commission, and several state-level partners. The size of the project was limited by the amount of match we had available. As a result

2011 LSTA Competitive Grant Program announced by Sonja Hudson, contracts/grants officer

The Idaho Commission for Libraries announces the 2011 Library Services & Technology Act (LSTA) Competitive Grant Program. The Commission's 2011 LSTA Allocation Plan describing the grant program can be found on the website at <http://libraries.idaho.gov/page/library-services-technology>. This document contains the grant timeline and an expanded version of the following information:

The Commission's competitive grants are awarded to eligible publicly-funded Idaho libraries with programs or projects that exemplify the purposes and priorities outlined by the U.S. Congress as eligible for LSTA support. The competitive grant process consists of a draft and a final application. Final applications are by invitation only. Final grant awards are made by the Commission's Board of

Library Commissioners at their February 2011 meeting.

The 2011 LSTA Grant Kit containing detailed instructions and all the necessary documents for applying will be posted on the Commission's website on or before May 21, 2010. Hard copies are available on request.

The first step for all applicants is to contact your regional library consultant and discuss your project. You can find contact information on the second page of the Allocation Plan or the Grant Kit.

Partnering to Shape 21st Century Learners conferences

The Partnering to Shape 21st Century Learners conferences—held in Boise, Coeur d’Alene, and Pocatello this spring—provided “an inspiring opportunity for professional development and networking...with the famous ‘Washington Moms.’ These fiercely dedicated women have spearheaded their grass-roots school library advocacy from a kitchen table in Spokane to the national spotlight,” said Boise school librarian Becky Proctor. “What a great day!”

School librarians served as team leaders and brought along an administrator and one or more parents to help formulate blueprints for their 21st century libraries.

Regional library consultant Frank Nelson highlighted the findings of the “Idaho School Library Impact Study-2009” (see the full report and Executive Summary at <http://libraries.idaho.gov/study>). The bottom line is that students are more likely to succeed when librarians play active and collaborative roles with both other teachers and with administrators. Conference participants discussed the value of collaboration on a regular basis, as well as communication between teachers and librarians about specific topics that students are studying.

Participants envisioned libraries of the future as “inviting spaces, safe places, cool hangouts, teen friendly, and wireless accessible, with a laptop for every student.” Libraries of the future would also promote global citizenship and include opportunities to network with other librarians.

Some nuggets from the Boise conference include the following observations:

- (From a student): Teach me the technology that I need. Teachers need to be aware so I can be prepared. Teach from your past for our future.
- Instead of teaching abstinence, teach safe surfing.
- FlipCams in every classroom is a must: this brings up level of accountability and students can see immediate feedback.
- Have students present technology to teachers during in-service.
- Task high school videographers to produce Public Service Announcements about Information, Communication and Technology (ICT) and 21st century skills to introduce those terms to parents and other stakeholders.

Participants contributed to “charrette” wikis, intended to be a starting point for drafting a sketch of what is necessary in order to develop strong, crucial partnerships and Library Information and Technology programs. Elements of what was accomplished in Boise, Coeur d’Alene, and Pocatello will be presented in October 2010 at a pre-conference of the Idaho Library Association’s Annual Conference.

LiLI-U Enrollment Deadline is May 20

The 2010 deadline for new participants to enroll in the LiLI Unlimited (LiLI-U) program is May 20.

It is more important than ever to consider how efficiently everyday tasks are carried out. With fewer staff and smaller budgets, where libraries invest their resources is crucial. Through LiLI-U, libraries in Idaho are leveraging their purchasing power with a statewide group subscription to OCLC's cataloging and resource-sharing tools.

Save time cataloging and get new books into the hands of patrons faster by using CatExpress to pull records from OCLC's WorldCat database. There are over 170 million MARC records in WorldCat from which to choose. Plus, interlibrary loan staff can borrow from more than a billion items held in libraries worldwide. The large numbers can be daunting, so here are two examples of the success Idaho libraries have seen with LiLI-U participation:

A small public library saves time.

In rural Idaho one busy summer day, the

librarian received a shipment of 64 new books. Using the CatExpress tool available through LiLI Unlimited, all 64 books were processed and entered into the circulation system in less than three hours. The librarian noted, "If I had been able to do this while the library was closed, I would have had them done even sooner!"

A high school art teacher saves money

Each year, the high school art teacher includes lessons that review great works of art. She read about two books, with full-color images of important pieces but, because she had never seen either title, she could not attest to their quality. Luckily, the librarian had access to LiLI Unlimited. Using the interlibrary loan system, she borrowed the items from other libraries. When they arrived, she found that one of the books was limited in content but the other would suit her needs well. In the end, the school avoided spending \$159 on a lesser-quality item.

HeritageQuest Webinar

Libraries may be seeing an increase in genealogy research these days. A television series showing some celebrities learning about their family history is bound to pique our curiosity. Luckily, Idahoans have free access to a great genealogy research tool, HeritageQuest.

HeritageQuest is a product of ProQuest and available at no cost to Idaho residents through the Libraries Linking Idaho (LiLI) Database program. The HeritageQuest collection consists of six tools to search U.S. Census records, local

history books, and more. This amazing resource can help any aspiring genealogist get started with their family research.

The Idaho Commission for Libraries has scheduled three 1-hour training sessions for library staff interested in learning more about how to use HeritageQuest. BCR and LYRASIS partnership by Gina Persichini

In early April the Bibliographical Center for Research (BCR) and LYRASIS announced they are Partners in Transition.

The Idaho library community will know BCR from the discounts, training, and consulting services provided for a number of years. For many years, all Idaho libraries have had member status with BCR through a statewide membership obtained by the Idaho Commission for Libraries. As a result, Idaho libraries have taken advantage of discounts available on databases, supplies, and training. Now, BCR will be joining forces with LYRASIS.

LYRASIS is a very large library network providing services similar to BCR. From their vision statement, "LYRASIS supports library and information professionals by providing opportunities for networking and collaboration and member services including education, group purchasing programs, digitization, preservation, consulting and advocacy."

So what does this arrangement mean for

Idaho libraries? There are a number of things Idaho library staff need to know about this change:

1. There will be no interruption of services as the transition takes place.
2. LYRASIS and BCR now share office space in Aurora, CO, to serve their western members.
3. Your membership will automatically transfer to LYRASIS membership on October 1, 2010.
4. Effective immediately, Idaho libraries are eligible to take advantage of LYRASIS training opportunities at member rates. <http://www.LYRASIS.org/Classes-and-Events.aspx>.
5. If you purchase products and services with BCR now, continue to do so through BCR. LYRASIS will honor BCR pricing through June 2011.
6. In addition to BCR's existing products and services, you now have access to an even wider selection of LYRASIS products and services <http://www.LYRASIS.org/Products-and-Services.aspx>. BCR

Support will help you navigate where to purchase these services during the transition (support@bcr.org).

BCR will schedule online Member Forums to answer questions and help introduce their members to LYRASIS. These will be announced through the BCR website and via the BCReview electronic newsletter. Those interested in keeping up-to-date on the news and service announcements from LYRASIS can subscribe to their mailing lists and regular electronic publications by going to <http://www.LYRASIS.org/News/Member-Subscriptions.aspx>.

As part of the transition process, the Idaho Commission for Libraries will be working with BCR and LYRASIS staff to determine the options for continued state or group membership with LYRASIS in future years. Updates are coming to ICFL website and LiLI portal

In order to comply with new website design standards for Idaho state agencies, the ICFL website has been undergoing a significant update. When the new site goes live at the same URL (<http://libraries.idaho.gov/>), you will find a new layout, look, and logo—but the same content, tools, and publications.

The LiLI Portal (www.lili.org/) is also being updated. In addition to complying with state standards, the portal revisions were designed to:

- make it simpler to access LiLI databases

- make it easier to use the LiLI Unlimited statewide catalog
- make it more straightforward to search for information

The portal also includes a "Getting Started" video for users and brief descriptions of the available databases.

We worked with a focus group to test the new design elements, making changes in a separate online location so ICFL website and LiLI users would not be inconvenienced by the construction.

The target "go live" date for the updated ICFL website and LiLI portal is July 1, 2010. We hope that you will like the new look and find the sites useful and efficient to navigate.

Your Summer Reading program

If you are an Idaho library planning to offer a children's and/or teen summer reading program, please prepare to collect participation statistics this summer and submit them to the Idaho Commission for Libraries by August 31. The questions we will ask and notes on collecting your data can be accessed at http://libraries.idaho.gov/files/2010_SummerReadingQuestions.pdf.

Summer reading program materials, such as Collaborative Summer Library Program (CSLP) program manuals and Bright Futures materials, are Library Services and Technology Act (LSTA)-funded. Libraries using the statewide theme or who are participating in Bright Futures, are required to submit their participation statistics to the ICFL. These statistics are used to fulfill reporting requirements issued by the Institute for Museum

and Library Services (IMLS), which administers LSTA at the federal level. Failure to report your data will jeopardize your library's eligibility for future summer reading materials.

We will collect your data using a Survey Monkey survey that we will send out in June. The survey should be completed by each library branch. Please do not send any data directly to ICFL staff.

Thank you in advance for collecting your data and submitting the information to us! Your information helps us demonstrate the amount of summer reading activity taking place in Idaho's libraries, and helps us continue to improve the services we offer to you.

Walmart Grant reports

Last year, as a result of a collaborative effort between the Idaho Library Association, First Lady Lori Otter, the Idaho Community Foundation and ICFL, the Walmart Foundation provided \$98,000 in one-time funds to support "Strengthening Library Services for Youth in Idaho."

The Commission distributed the funds through a competitive mini-grant process open to all Idaho publicly-funded public libraries. The grant program was designed to encourage creative thinking and

new approaches in order to provide innovative services and help libraries reach more youth from birth to age 18 and their families. Grant awards ranged from \$1,000 to \$10,000.

The Walmart grant reports were due April 30, 2010 and synopses of projects are being posted on the ICFL website. Career Information System (eCIS) subscriptions to continue

Here is some good news for Idaho public libraries using the Career Information System (CIS) tool provided by the Idaho Department of Labor since September 2009. The CIS subscription will continue at NO charge to your library after August 31, 2010. Subscriptions will continue for those Idaho libraries without cost and without interruption.

CIS received a grant that covers a significant portion of the costs to the current subscribers (schools and libraries).

Here are the details:

1. A contract will not be required.
2. Service will continue, MINUS the

- following Exploration Tools: Career Focus, SKILLS, Work Importance Locator, and Career Cluster Inventory.
3. Login and password stay the same.
4. No user reports will be provided.

The people at CIS are working on a Public Access (PA) model, which will be ready sometime after January 1, 2011. The PA model is what libraries currently subscribing to CIS will be using after August 31. It will be available to other Idaho public libraries sometime in 2011.

Paint the State Contest

The Idaho Meth Project launched a statewide public art contest—Paint the State—that encourages Idaho teens to create artistic representations of the dangers of methamphetamine use. Idaho teens ages 13–18 have the opportunity to create public art that communicates an anti-Meth message surrounding the theme: “Not Even Once.”

Winners will be selected by local judging panels and \$3,000 in prizes will be awarded in each of Idaho’s 44 counties. First place winners from all counties will compete for the statewide Grand Prize of \$5,000. Winners will be announced at a special art gala featuring Governor C. L. “Butch” and

First Lady Lori Otter in Boise on August 6. The Project is asking libraries across the state to help promote this program by:

letters of support will be considered by the selection committee.



SWIM scholarship recipients

Nampa Public Library

Mark Rose began his work as the new Nampa Public Library director on April 26th. For the past five years, Rose served as the Director of the Marion Public Library, in Marion, Ohio. He spent two years prior to that as the Assistant Director of the Provo City Library. Rose received his MLIS from Brigham Young University, and before beginning his library career served as a First Lieutenant in the U.S. Army for four years. Former director Karen Ganske retired in March.

Idaho Humanities Council Grants

The National Endowment for the Humanities awarded several Idaho libraries the *Picturing America* package of 40 reproductions of American masterpieces. The Idaho Humanities Council awarded six grants for library programs exploring these masterpieces:

- **American Falls District Library: \$500** for a Veteran’s Day commemoration
- **Blackfoot Charter Community Learning Center: \$500** for classes on Native American history
- **Burley Public Library: \$500** for a presentation on the Bill of Rights
- **Coeur d’Alene Public Library: \$1,000** towards a program titled “Fiber & Fabric: Art Born of Necessity”
- **Hayden Library: \$1,800** for three speakers in an eight-month series on topics from literature to history
- **Jerome Public Library: \$650** for student and adult art classes

Ada Community Library

On behalf of Idaho libraries, archives, and museums, Ada Community Library submitted a successful grant application, “Idaho Connecting to Collections,” to the Institute of Museum and Library Services (IMLS). With the awarded funding of \$39,500, the library, in cooperation with museums, libraries, and archives across Idaho, will conduct the first-ever statewide survey to identify preservation needs among collections-holding institutions. This information will be useful in developing a plan for proper care of collections and will allow the creation of a collaborative network among cultural heritage communities.
