

# IDAHO BOARD OF LIBRARY COMMISSIONERS SPECIAL MEETING MINUTES JULY 28, 2021, 10 A.M. MDT HELD VIA ZOOM VIDEO CONFERENCE & AT THE IDAHO COMMISSION FOR LIBRARIES, BOISE, ID 83702

The Idaho Board of Library Commissioners meeting was called to order at 10:08 a.m. MDT on Thursday, July 28, 2021. Participating in the Boise office was State Librarian Stephanie Bailey-White.
