C. Bucks for Books Grant Applications Received – Information item

The Idaho Commission for Libraries is partnering for the fourth year with the Idaho Lottery on Bucks for Books, a program that helps Idaho elementary school libraries purchase the books students need to become proficient readers. The Idaho Lottery Commission provided \$50,000 for the program this fiscal year. Nineteen elementary school libraries received awards ranging from \$1,000 to \$3,000. The ICfL staff manage the application process with two reviewers from the Idaho Lottery Commission on the grant review panel. This year, 32 schools applied for the program, requesting \$84,000 in funding.
