V. Federal Fund

A. Finances – FY2024 Federal Program Budgets – Information item

The Idaho State Legislature authorized the Idaho Commission for Libraries (ICfL) to spend up to \$3,608,100 in federal funds and a re-appropriation of \$250,000 in Digital Access for All Idahoans (DAAI) planning funds for FY2024 in the following spending categories:

ICfL project leads develop budgets for the fiscal year. Those budgets are approved or adjusted by the ICfL management team, then monitored by the team each month. The ICfL's actual allotment of Library Services and Technology Act funds from the Institute of Museum and Library Services is \$1,740,506 for the federal fiscal year (October 1 to September 30). The management team reviews and adjusts budgets during a mid-year scrub to prevent spending over the appropriation and continually evaluate agency needs.
