## C.2. Grants – American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER) Grant Applications Received – Information item

The Idaho Commission for Libraries received federal American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER) funds to distribute to Idaho libraries. The purpose of this funding is to help entities address unfinished learning in their communities due to the COVID-19 pandemic.

The ICfL is investing this \$1.25 million over two years, offering grants and resources for libraries to support learners in grades K-12. This is the second year of the following grant opportunities:

- **Out-of-School Time (OST) Planning Grants** of up to \$15,000 for library systems or school districts to strategically develop services and programs for youth.
- **Out-of-School Time (OST) Programming Grants** of up to \$3,000 for library locations to use research-based best practices in programming with youth.
- Summer Learning Strategies Grants of up to \$20,000 for library systems to use research-based strategies to build high-quality summer learning programs that align with the library's mission and strategic plan.
- **Summer Support Grants** of \$2,000 for libraries to enhance current summer learning or summer reading programs.
- **Summer School Library Grants** of up to \$7,000 for school libraries to remain open during the summer months.

So far this fall, the ICfL has awarded a total of **\$298,000 in ESSER OST Planning, OST Programming, and Summer Learning Strategies grants**. They are detailed below. Summer Support Grants and Summer School Library Grants will be awarded in early December 2023.
