C.4. Grants – That All May Read Grant Awards – Information item

The Idaho Commission for Libraries' That All May Read Grants are designed to assist public libraries in improving equitable access to reading materials in alternate formats for Idahoans unable to read standard-print books. The \$1,000 grants allow libraries to build large-print collections, obtain assistive technology, and/or provide outreach to individuals with visual impairments, blindness, perceptual or physical disabilities, or difficulties holding books. Promoting the Idaho Talking Book Service is a grant requirement for libraries accepting funds.

This is the third year of the grant program. The ICfL received 28 applications in FY24 and was able to fund all of them.
